I. APPLICATION CRITERIA

Teamsters Local Union No. 222 Scholarship Fund will award **Twenty (20)** scholarships for a total of \$25,000.00 to outstanding high school seniors. Due to the great number of applicants to this program, all applications must comply with the following eligibility and application criteria.

Each applicant must:

1. Be the son or daughter of an active and/or disabled Teamsters Local 222 member who is in “good standing” in Teamsters Local 222 as defined in Article X, Section 5 of the International Constitution.
2. Be in his/her last year of high school and may not apply if he/she has already graduated from high school.
3. Have a grade point average of 3.0 or better.
4. Be among the top twenty applicants, ranked by GPA and SAT (or ACT) scores.
5. Plan to attend an accredited college or university. Check will be written to the school.

II. APPLICATION PROCEDURE & ADDITIONAL REQUIREMENTS

1. Applicants must submit:
 - a. Application (PART III);
 - b. Academic Record completed by applicant’s guidance counselor or equivalent high school official (PART IV);
 - c. an official high school transcript;
 - d. SAT and/or ACT results;

V. ADDITIONAL RULES AND REGULATIONS

ADDITIONAL RULES & REGULATIONS GOVERNING THE TEAMSTERS LOCAL UNION NO. 222 SCHOLARSHIPS FOR THE COLLEGE ACADEMIC YEAR 2021-2022.

Children of current employees or elected officials of Teamsters Local 222 are not eligible to apply.

Recipients must be graduating from High School during the academic year of 2020-2021.

A scholarship award may be utilized for tuition and/or book fees. Checks will be made payable to the school.

Recipients must utilize a scholarship award for the academic year 2021-2022 with exception to a qualifying deferral as outlined below:

QUALIFYING CIRCUMSTANCES FOR DEFERRAL OF SCHOLARSHIP AWARD

1. If the recipient is unable to attend college due to an illness certified by a physician, the scholarship will be held in abeyance for not more than one year.
2. If schooling is interrupted by military service, scholarships will be held in abeyance for not more than two years, unless the military service is of such a nature as to warrant special consideration beyond that time. When returning from military service, the scholarship recipient must notify the Scholarship Fund and apply for readmission within 90 days and return to school within six months thereafter.

Teamsters Local 222 reserves the right to review the Teamster parent's membership status with the local union at any time. Suspension from Teamster membership for non-payment of dues or for any other reason will result in forfeiture of the scholarship.

Any scholarship award not claimed by the end of the 2021-2022 Academic year will be forfeited.
