This Letter of Understanding (collectively the "Agreement") has been entered into by DFA Dairy Brands, LLC ("Company"), Teamsters, Chauffeurs, Warehousemen & Helpers State of Utah, State of Wyoming Construction Division Local Union No. 222 ("Local 222"). The Union and the Company are each a "Party" to this Agreement and are collectively referred to as the "Parties." By a Letter of Understanding dated September 1<sup>st</sup>, 2024, Local 222 and the Company agreed that all employees who are within the Plant Maintenance Department & the Pasteurizer classification will adhere to this Letter of Understanding.

In an attempt to recruit new talent and as well as to ensure employee retention within the Plant Maintenance Department & Pasteurizer classification the parties agree to the following: In an addition to the yearly CBA wage increases, the following classifications will receive an hourly market wage adjustment outline below:

<u>Guidelines</u>: Pasteurizers and employees within the Plant Maintenance Dept. are appointed positions by management with extra pay and the possibility of longevity pay. Skills and abilities as outlined within shall take precedence over seniority, unless multiple applicants are equally qualified then seniority would prevail. (Electrical, Mechanical, Pneumatic, hydraulic aptitude test administer by

plant engineer. Pasteurizer will have food handling knowledge GMP, Processing and CIP.). Any disputes between the Company and the Union would be subject to the grievance procedure. Employee(s) / Applicant(s) must be "job ready" (Maintenance as determined by the plant engineer, and maintenance manager and plant manager. Pasteurizer determined by Production manager and plant manager) to assume these positions. The Company will train those employees internally who are willing to become Pasteurizers or Plant Maintenance Technicians, provided they agree to take the next opening. If no employees are job ready, that would necessitate a bid and if an internal employee wins the bid, they will be awarded the bid before the Company hires someone from outside and trains the new employee.

<u>Disqualification</u>: An employee who enters the Pasteurizer classification and then leaves the classification may lose their longevity pay (if applicable) as well as having their hourly wage adjusted to the "Bracket Pay" consistent with the CBA.

To ensure employee retention and to acknowledge the years of service with Meadow Gold, Tito S. Rodas will receive a one-time wage adjustment effective on September 1st, 2024, to \$31.00.
